This Privacy Policy is provided in compliance with the art. 13 - 14 of the GDPR 2016/679 (European regulation on the protection of personal data), of the Recommendation n. 2/2001 of the Working Group pursuant to art. 29 and of the General Provision of the Privacy Guarantor concerning cookies of 8 May 2014, n. 229 (Cookie Law).

Information on the Data Controller:

The Data Controller is Nadirex International S.r.l., based in Via Riviera, 39, Pavia (PV), in the person of the Legal Representative.

Purpose of the processing and mandatory provision:

This Site deals with data that the user spontaneously inserts through the forms on the site (Contacts - Contact Form) solely to respond to your request. Any other purposes will be the subject of an explicit and justified request and your specific, optional and separate consent from the one required to answer your questions.

The provision of data and consent to processing are necessary to follow up on your requests; consent to the processing for further purposes is optional.

For data acquired from our site through the installation of cookies, refer instead to the specific section ("Cookies").

Processing methods, automated decision-making processes and time frames data retention:

The processing of your data takes place in an informatic manner, although potential treatments in paper form are not excluded. No automated decision-making processes are used to process your personal data.

The personal data concerning you, collected through the form of our site, will be kept for the time necessary to respond to your requests. Where there is additional legislation to impose longer retention time, this legislation will be respected by us. The data collected through cookies will be kept for the period of time established by the individual cookie.

Cookies:

Cookies are data that are sent from www.nadirex.com to the user's Internet browser and are stored by it and then sent back to the site at the next visit.

They can be used to monitor sessions, to authenticate a user so that he can access a site without typing the name and password each time and to memorize his preferences.

There are many types of cookies classifiable for technical aspects, duration, origin and function.

Technical cookies:

There are many technologies used to store information on the user's computer, which are then collected by the sites. Among these the best known and used is that of HTML cookies.

They are used for navigation and to facilitate access and use of the site by the user. They are necessary for the transmission of communications on the electronic network or the supplier to provide the service requested by the customer.

The settings for managing or deactivating cookies may vary depending on the Internet browser used.

In any case, the user can manage or request general deactivation or cancellation of cookies by modifying the settings of his Internet browser. This deactivation can slow down or prevent access to some parts of the site.

The use of technical cookies allows the safe and efficient use of the site.

The cookies that are inserted in the browser and retransmitted by Google analytics or the statistics service of Blogger or similar are technical only if used for the purpose of optimizing the site directly from the owner of the site, which can collect information in aggregate form on the number of users and how they visit the site. Under these conditions, for analytics cookies the same rules apply, in terms of information and consent, provided for technical cookies.

Profiling cookies:

Profiling cookies are designed to create profiles related to the user and are used in order to send advertising messages in line with the preferences expressed by the same in the context of surfing the net.

Third-party cookies:

By visiting a website you may receive cookies from both the visited site ("owners") and from sites managed by other organizations ("third parties"). TECHNICAL COOKIES

Third-party and analytical cookies can be installed. They are sent from the domains of the aforementioned third parties external to the site.

Third-party analytical cookies are used to detect information on user behavior on this site. The survey takes place anonymously, in order to monitor the performance and improve the usability of the site. The third-party profiling cookies are used to create profiles relating to users, in order to propose advertising messages in line with the choices expressed by the users themselves.

The use of these cookies is governed by the rules set by the third parties themselves, therefore, users are invited to read the privacy policies and indications to manage or disable the cookies published on the related web pages.

Browsing data:

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes IP addresses or domain names of the computers used by users connecting to the site, URL addresses of requested resources, the time of the request, the method used in submitting the request to the server, the file size obtained in response, the numerical code indicating the status of the response given by the server and other parameters related to the operating system and the user's computer environment.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.

The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site: except for this eventuality, at present the data on web contacts do not persist for more than seven days.

Data provided by the user:

The optional, explicit and voluntary sending of e-mails to the addresses indicated on this site entails the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the message.

Specific summary information will be progressively reported or displayed on the pages of the site prepared for particular services on request.

Communication, dissemination and transfer of data to third countries or international organizations:

Your data will not be disclosed or disseminated, without its specific and optional consent, to third parties. The data you provide will not be transferred by us to third countries or international organizations outside the EU.

Rights of the interested party and complaint to the Privacy Guarantor:

You have the right to request us at any time access to data concerning you, their modification, integration or deletion, limitation or opposition to their processing, where there are legitimate reasons, as well as the portability of the aforementioned data to another Data controller. We will provide you with a written reply within 30 days. You may revoke, at any time, the consents provided on this site, by contacting one of the addresses indicated in the paragraph "Information on the Data Controller and on the possible Data Protection



Officer". It is also possible to lodge a complaint with the National Supervisory Authority, where you believe that your data have been treated illegitimately.
